## Backing data integrity with a first-of-its-kind API

Leading space-based intelligence company BlackSky partnered with Clearsulting to streamline SEC reporting processes by connecting its OneStream financial system to Workiva with a first-ofits-kind API. With operations across engineering, manufacturing, and advanced satellite and AI technology solutions, BlackSky operates in a highly regulated environment where financial accuracy, data integrity, and federal Sarbanes-Oxley (SOX) compliance standards are nonnegotiable.

## The challenge

As a growing publicly-traded company, BlackSky sought to optimize SEC reporting efforts with specific interest in applying software mechanisms that saved time, increased transparency, and reduced risk. The small-but-mighty financial reporting team had been spending inordinate amounts of time on manually repetitive tasks such as control evidence collection (now minimized through log files confirming inter-system connection), in-person follow-ups, and manual testing documentation with legacy spreadsheet systems that made preparation for SEC filings unnecessarily difficult.



## How we worked together

### The solution

Clearsulting helped BlackSky connect Workiva to their OneStream financial system with a novel API solution, enabling dynamic data flow between compliance and financial reporting systems. This integration allowed for automated population of control testing data, enhanced traceability, and improved alignment between operational controls and financial outcomes. It also:

- Automated control performance tracking and testing in Workiva
- Enabled real-time visibility with dashboards and audit trails
- Provided a centralized repository for control documentation and evidence
- Underpinned data consistency between Workiva and OneStream, eliminating human error
- Automated alerts and certifications for control owners

### Time savings and efficiency gains

By the time of go-live, the BlackSky finance team realized significant gains in reporting efficiency. Centralized data and streamlined workflows reduced reliance on manual processes with the team saving approximately 40 hours per SEC reporting cycle. The Workiva-OneStream integration proved especially valuable—control testing data flowed directly into compliance dashboards, allowing the finance and legal teams to work from a shared, real-time source of truth.
